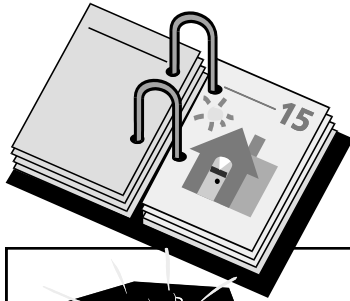

General Meeting – ESBCCH April 20, 2011

Meeting was called to order at 7:04 pm at the Conrad Public Library by President Bob Hermance.

Members present: Bob and LeAnn Hermance, Ron and Debbie Ries, Fred Fitzpatrick, Dick Kinyon, Bill Poser, Gary and Connie Manning, Steve Hutton, Kurt Dyer and Don Cleveland. Guests were Ian Bardwell and Karen Horn.

Special presentation was given by Ian and Karen on Black Leaf Trailhead project. Project will increase horse trailer access and improve out house facilities. Present time there is not a designated camping area for the rock climbers. E-mails and letters were sent to rock climbing groups for comment, but none were received. Also work will be done at the Cave Mountain campground.

With funding cut backs, they are not sure what will be coming out. Last year's capital investments went to Gates Park; this year will be back on trail maintenance. Connie asked about the recreational trails grants. The process has changed so the grant working group only reviews the grant apps that were pre-judged and pre-approved. Gates Park contractor is Richard Mays from

California. This work should start this summer but currently snow pack is 1025% from last year.

Trail Management Objectives (TMO's) – Connie questioned the trail classifications being reclassified downwards. Ian provided a classification form on how decisions are made and that there will be no changes without notice. Class 2 trails to be managed to a pack & saddle standard. The maintenance decisions are based on use patterns of trails. Dick K. recommended the use of chain saws for a limited period of time in the burn areas, trails could be cleared faster than using a saw. More trails cleared with less manpower. Ian recommended doing a BCH regional and national resolution addressing this issue. Decisions on chain saws are not allowed at the district level. TMO's on RMD are completed.

Approval of Minutes, Steve Hutton moved to accept the minutes as published, Connie Manning 2nd, motion carried.

Treasurers Report: Fred Fitzpatrick gave the treasurer's report. Bills presented were Connie Manning for \$47.78, ink and newsletter costs, Kurt moved to accept treasurer's report as given and to pay bills, Steve Hutton 2nd, motion carried.

Correspondence – Connie read a letter from Lewis & Clark County on improving the Benchmark Rd. Project will be from Augusta to Bench Mark. Request a letter of support for the project. Fred F. moved that Connie draft a letter of support, Dick K 2nd, motion carried.

Committee Reports – Fred Fitzpatrick attended the LAC meeting in Choteau. Issues brought up were the following;

Kevin Arnold will do spot checking on proper food storage in camp. New water proof maps of BMW will be available in June. White Nose Syndrome (WNS) is affecting bats in the backcountry. Check with Forrest

Service before going spelunking. Holly Baker presented a slide show on the RMF. Ranger districts will be doing weed mapping. Greg Schatz, FBCH, presented bicycle resolution in the back country. Asked what the fine is for bike trespass in the wilderness. Potential fines \$125 to \$5,000. FWP update, there are 566 wolves in 100 packs in MT. There are 6,000 Elk along RMF, highest number in years. Jim Brogger lost a calf due to wolf kill. Combo hunting licenses are available on line April 18th. They will be planting cut throat at Nichols lake August 29th. Seely Lake will have 2 MCC crews this year with 10-12 people out of Big Bear and Schaeffer Meadows.

Unfinished business- Swift Dam sign project. Ron and Fred are in charge of the project. We will need three signs, entrance, midway and upper campground. Sign size 2' x 18", cost \$270.00. Kurt will donate posts. Dick Kinyon moved to accept sign design, Connie M. 2nd, motion carried. Connie M. moved to buy cable and supplies for high line, Kurt D. 2nd, motion carried.

Connie M. reported that at the directors meeting the discussion was to recommend that annual & new membership's apps be reviewed. This will be done at the next directors meeting. Directors meeting on May 4th cancelled.

Next general meeting will be May 18th, 7pm at the Conrad Public Library.

No further business, meeting adjourned at 9:10 p.m.

Swift Dam Memorial Day Work Project

May 27-30, 2011

This project will be the construction of a permanent high line for horses (no mules) it will be constructed east of the main building towards the fenced pasture area and running parallel with the pasture fence. The high line will consist of three power poles buried in the ground and running 100 feet in length with one pole in the center at 50 feet. A 1/4 inch steel cable will be strung between the power poles and swivels with steel rings will be attached to the cable with cable clamps for securing stock to the high line. The high line will have a spring assembly for allowing give in the

cable, thus allowing stock basically the same movement as on a regular rope high line; (in theory).

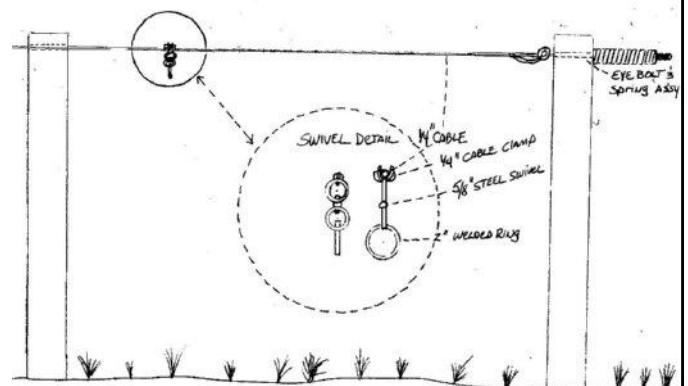
We will also be putting up some new signs at the campground that will address the loose horses in the campground.
